WITHIN THE FRAMEWORK OF TRAUMA-FOCUSED COGNITIVE BEHAVIORAL THERAPY (TFCBT) THE CLINICAL SERVICES TEAM PROVIDES A SAFE SPACE FOR CHILDREN TO IDENTIFY AND OVERCOME CHALLENGES, DEVELOP POSITIVE COPING SKILLS AND BUILD HEALTHY RELATIONSHIPS THROUGH TALK THERAPY, PLAY THERAPY, ART THERAPY, SAND-TRAY THERAPY AND OTHER MODALITIES PROVIDED TO CHILD VICTIMS, THEIR NON-OFFENDING CAREGIVERS, AND SIBLINGS. AT AN OFFICIAL MEETING OF THE BOARD OF DIRECTORS, THE COMPENSATION COMMITTEE PRESENTS ITS RECOMMENDATION, INCLUDING THE COMPARABLES ON WHICH THE RECOMMENDATION IS BASED, TO THE REST OF THE BOARD FOR CONSIDERATION, DISCUSSION AND A VOTE.
